Code of conduct for board members, coaches, parents, and players:

The purpose of the Redfield Athletic Association's sports is to teach youth how to play sports in a competitive atmosphere while also teaching the lesson of teamwork and sportsmanship. As board members, coaches, and parents, we have taken on the responsibility of leaders in this league. This league is for the youth, not a proving ground for adults. The games can be very competitive and have moments where we disagree. As leaders of this league and of the participating youth, we must always maintain control of our emotions and treat others the way that we want to be treated. We are the example for the youth of this league. The following list of rules shall be enforced by the RAA.

1. No loud profanity will be used in the gym.
2. The use of alcoholic beverages or drugs will not be allowed on the Redfield Community Center property.
3. The use of tobacco products will not be allowed on the Redfield Community Center property.
4. Shouting matches among parents, coaches, players, and umpires will be prohibited.

The penalty for breaking these rules will be as follows:

- First Violation - Verbal warning
- Second Violation - Asked to leave gym under your own power or police escort for the current activity
- Third Violation - Not allowed back in gym depending on the severity of the violation as voted on by the board

**Facility Use Waiver and Release of Liability
Redfield Community Center**

When entering the premises, I understand that I am liable for any and all injuries, and theft or damage to personal property.

By signing this waiver, you are stating your desire to utilize Redfield Community Center and acknowledging and agreeing to the following:

I agree that if I engage in any activity at Redfield Community Center, I do so at my own risk. This includes, without limitation, my use of the gym, rooms, kitchen or any equipment in the Community Center and my participation in any activity, class, program or instruction. I agree that I am voluntarily participating in these activities, and using these facilities and premises, and assume all risk of injury, illness, and damage to myself, and any loss, damage, or theft on any personal property, without limitation. I agree on behalf of myself and my personal representatives, heirs executors, administrators, agents, and assigns, to release and discharge Redfield Community Center/Keep Redfield Middle School, their affiliates, agents, representatives, successors, and assigns from any and all claims or causes of action, known or unknown, arising out of their negligence. This waiver and release of liability includes, without limitation, injuries which may occur as a result of: (a) my use of this facility, (b) negligent instruction or supervision, (c) my slipping and falling while on the premises, and (d) my use of the services.

I acknowledge that I carefully read this waiver and release and fully understand that it is a release of liability. I am waiving any right that I may have to bring legal action against or assert a claim against Redfield Community Center for negligence. Use of the facilities is at my own risk and I will not hold any party liable for any injury or damages resulting from my use of services and facilities.
